This recall has been initiated due to the out-of-specifications (OOS) impurity results obtained during routine quality testing of a stability sample for one lot of Sodium Phenylbutyrate Powder, 250 Grams. This recall is being extended to all other potentially impacted lots as mentioned in the table above. Use of this product is not likely to cause any adverse health consequences.

We began shipping this product on August 31, 2020.

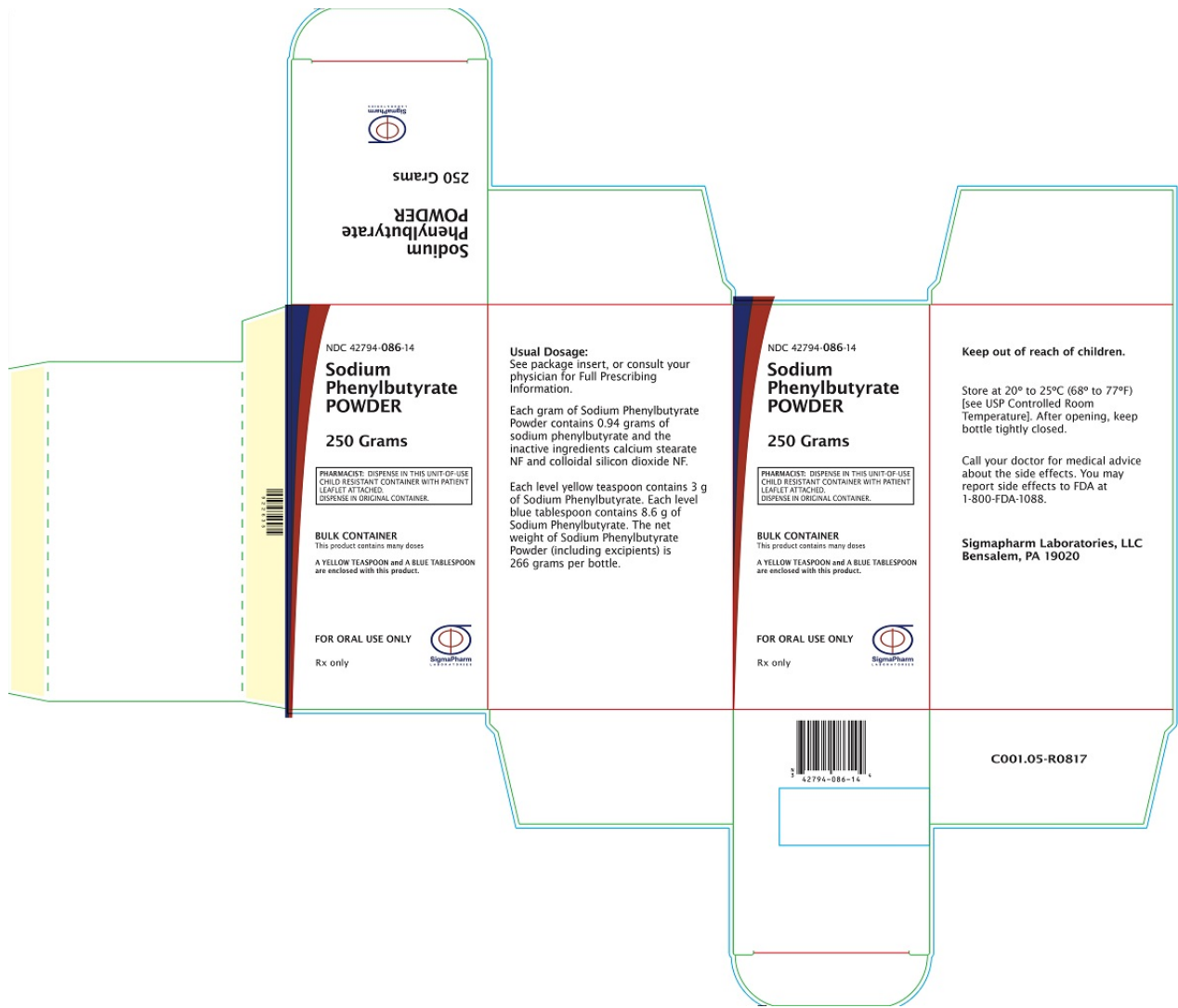
